Service as an official representative of the University, beyond job responsibilities.

Per the service section of my CV, I am an active participant in a majority of our SOAR sessions each year and have been a representative of MSU and our music unit at multiple "Meet MSU Nights," open houses, and college fairs since joining the faculty. I have visited 30 school band programs in my time at MSU as a guest conductor/clinician.
